This orientation explores an unfolding process of discovering oneself. It assumes we are responsible for how we exist in the world and how we respond to the conditions and challenges presented to us. Major coursework included Theories of Psychotherapy, Group Therapy, Theories of Personality Development and Abnormal Psychology. To maintain my license I am required by the state to participate in annual continuing education. I participate in classes dealing with subjects relevant to this profession. I may substitute professional/peer supervision for part of this requirement. I will be happy to explain what that entails and how it relates to you as my client.

My fee schedule is as follows:

One session of individual, couple or family therapy is \$125.00 per hour.

One session of individual clinical consultation is \$125.00 per hour

One session of clinical supervision for registered interns is \$120.00 per hour

Existential Humanistic Case Consultation group: 2.5 hour-long group. \$70 per group session, ten session series, commitment is for the whole series (\$700). There is an additional \$5 per group charge if the participant wants CEs.
